IMPORTANT INFORMATION		
3.	Eligibility: Who may enter the Competition?”	To enter the Competition a participant must be in possession of a valid South African identity document or passport (“ Participant ”). No Minors are allowed to enter the Competition.
4.	Who cannot enter the Competition?	The Competition may not be entered into by any director, member, partner, employee, agent, consultant, tenant of the Landlord at the Mall, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
5.	Competition Period:	The Competition Deal of The Month will run from 26 September – 1 st October 2023 on the Horizon View Facebook page and WI-FI landing page, (“ Competition Period ”) Please be advised that the Competition will only take place on the Competition Period and any participation outside of the Competition Period will not be taken into consideration.
6.	How to enter?	To enter the Competition, a Participant will be required, for the duration of the Competition Period to: i. Participant must log on to Horizon Shopping Centre WI-FI and sign up between 26 th September and 1 st October 2023 or use the Wi-Fi between the competition dates.
